- With 90% of our members laid off at the height of the pandemic, the local faced a stark and sudden decline in our income;
- Local took immediate measures to mitigate costs:
  - Applied for federal subsidies/relief available to the local (CEWS and CERS);
  - Made cuts to staffing costs;
  - Received relief from IU.
  - Negotiated vendor contracts at lower prices;
  - Cleaned up data which resulted in per capita credits.
- Local has healthy reserves.
- Essential as we face steep decline in income throughout the pandemic where in some months we operate in the red.

Not only is climate action the right thing to do, it is the smart thing to work on. Our union will commit itself to joining in the fight for climate justice, seeking to transform our workplaces into low-carbon operations that reduce energy use, waste, and greenhouse gas emissions, while protecting workers and training for the jobs of the future. We will undertake a comprehensive approach to becoming leaders in sustainability, which includes:

### PRESIDENT'S CLOSING REMARKS:

### Updates:

Brother Warsame thanked everyone for participating in tonight's meeting. It has been a tough year and a half during this pandemic. Since the State of Emergency was declared, the Union lost 90% of its membership to layoff overnight. The main focus of the Union was how to best take care of our members at this difficult time and how to ensure the viability of the Local in the future. The Union was able to extend full benefits for 100% of the members and strengthen job security language with agreements with all Employers with the extension of recall rights. The Union was able to negotiate 3 new collective agreements with the Union standard during the pandemic. With government support, the Union was able to establish the virtual Hospitality Training Action Centre 75 to provide numerous courses to the members with no out of pocket expense to the members. The Union continued to lobby the Government for hospitality workers for extension of Employment Insurance or if there was an industry bailout, that workers were included. Brother Warsame asked that we keep members lost during this difficult year in our thoughts.

Brother Kiran Panikar said that Brother Guled Warsame and his team did an amazing job. He thanked Brother Warsame for his leadership in extending recall rights and benefits, and thanked the Officers and Local 75 staff for their hard work during this difficult time.
